Greetings Everyone! I hope this letter finds you in good health & best wishes to you all in 2011/2012. I would also like to take this opportunity to thank you for your business this past year.

PLEASE MAKE NOTE:

Your current policy will expire on September 1, 2011. The purpose of this notice is to inform you that the 2011 – 2012 Vendors of the U.S. policy is now available for purchase! We will be able to start issuing certificates as soon as we have our new policy number. Sorry, we do not take credit cards. You need to mail the completed renewal application back to us with your check or money order. Please allow two weeks for processing.

Note:

Product coverage is not available if you are selling: firearms, fireworks, swords, knives, infant products, medical products, nutritional products & supplements.

Important Updates:

- Insurance companies are increasing all premiums this year by 5%. According to our broker, insurance premiums have not been adjusted in the last 10 years. Our premium was negotiated and we incurred less than a 3% increase (or \$10).
- Our policy still has **ZERO Deductible** for future claims!
- No charge for additional insured certificates!

Additional Insured Requests:

There is still **no charge** for additional insured certificates. All you need to do for your **free certificates** (many other companies will charge you a minimum of \$30 for each certificate) is submit your requests **in writing**. If you request through our website using the online certificate request we will email you back a PDF copy for your records and will fax or email wherever else you want your certificate to go. If you request by faxing we will fax your certificate back to the fax number(s) you provide. If you request through the mail we will mail your certificate back to you.

We need you to print or type clearly. Incomplete or non-legible requests will not be processed.
